

# Fees and Financial Information

(For the academic year September 2025 to July 2026)



## **Registration & Acceptance of Offer** (non-refundable)

Registration fee	£150.00	(inclusive of VAT)
Deposit on Acceptance of Offer into Nursery classes	£2,000.00	(VAT exempt)
Deposit on Acceptance of Offer into Reception and KS1	£3,000.00	(inclusive of VAT)
Deposit on Acceptance of Unconditional Offer (from Nursery into Reception)	£1,000.00	(inclusive of VAT)

Deposits are offset against the last term's fees and any VAT required to be paid from time to time will be added.

## **Notes:**

1. The Deposit payable on acceptance of an offer of a place at the school must be received by the date specified in the Office.
2. The Deposit is **not** refundable in the event that the place originally offered and accepted is not subsequently taken up by the child concerned.
3. All children in Nursery accepting a place for Reception during the Spring Term, will have their Deposit and Terms and Conditions transferred to this intake, thereby securing their place.
4. The Deposit held will be repaid to parents, without interest, when the child leaves the school if and only if all the School's Terms and Conditions regarding Notice on the Withdrawal of a Child have been satisfied in accordance with the general Terms and Conditions.

## **Notes:**

1. Fees listed above are without VAT. On 29 July 2024 the Chancellor announced that as of 1 January 2025, all education services supplied by a private school will be subject to VAT at the standard rate of 20%. All Nursery fees are VAT exempt.
2. Fees are payable on or before the first day of each term.
3. A full academic term's notice in writing or an academic term's fees in lieu is required prior to withdrawal of a pupil from the school. For the avoidance of doubt, "one full term" runs from the first day of term to the last day of a term and not a period covering parts of two terms. 4. The school reserves the right to charge a £100.00 (plus VAT if applicable) administration fee in respect of any term's fee which is paid late.
5. School fees are inclusive of all lessons including, e.g., school trips, swimming, violin/cello lessons, French, singing lessons, dance, drama, and after school clubs for Year 1 and 2.
6. The school fees exclude the cost of all snacks and meals.
7. The school does not participate in the Early Years Funding Scheme for free Nursery Education.

## **Workplace Nursery Schemes**
